



APPLICATION for ICSBF – MEMBERSHIP
Status: Associate Member

Dear ICSBF Membership Applicant,

The International Catch'n Serve Ball Sports Federation (ICSBF) was founded in November 2023. It, is a non-profit association, composed of National Catch'n Serve Ball Sports Federations and any sports associations practicing it.

Primary objects are the promotion and development of Catch'n Serve Ball sport discipline, as well as the access to team sports, in particular the sport of Catch'n Serve Ball (an easy access team sport in which the ball is caught and thrown over the net), and whose purpose is also to primarily promote equality in sport.

Associate Membership

If you are an international, national, regional sports organization, sports club and association that practices Catch'n Serve Ball and pursues the same goals and values as the ICSBF, without "Catch'n Serve Ball" in your name, you have the right to:

- be informed of ICSBF activities and accounts;
- participate at the General Assembly.

An Associate Member has no voting rights and its representatives are not permitted to run for an ICSBF position.

Membership Fees:

As founders of ICSBF, we have decided that for the year 2024 no membership fees will be requested to all members.

This decision is due to the fact that the Federation was founded on a participatory approach, which means that a broad movement must first be developed that can participate democratically from the beginning in order to create the preconditions for the future of the Catch'n Serve Ball network throughout the world. Amount and payment period of the member fees for the following years shall be decided together at the 1st General Assembly.

Application – Deadline: 31st of January 2024

As all major decisions in ICSBF are to be made jointly and democratically, right from the beginning on, there will be a simplified and shortened application procedure during the initial stage/step at the very first beginning. A first general assembly with elections for the decision-making body has to take place as soon as possible.

Therefore, all organizations that have duly submitted their applications by 31st of January 2024 at the latest and have been positively assessed, are entitled to provisional temporary admission.

In future, the admission procedure will require a longer period of time and a control phase, but application is possible anytime. Final details are to be worked out in the 1st General Assembly. The official language of ICSBF is English.

START YOUR APPLICATION PROCESS: ASSOCIATE MEMBERSHIP

If you are willing to start the application process, following **BASIC CRITERIA** must be fulfilled:

- You have to be a democratic, as well as sports for all – related organization.
- You have to be an international, national, regional sports organization or sports club that practices Catch'n Serve Ball.

In **STRUCTURAL TERMS** you can apply for membership, if

- you are a non-profit organization
- you are a non-governmental organization whose aims contribute directly or indirectly to the vision, mission, objective and functions of the ICSBF, or
- you are a governmental body, agency, institution and local authority that is responsible for sports, women, children, youth, elderly and social development fields, or
- you are an institution such as University, Academy, Research Centre or Parliamentarian Group interested in sports matters, or
- you are a company sports organization, or
- you are an independent trade union.
